





#### **PBB/PBDE Testing Flow Chart**





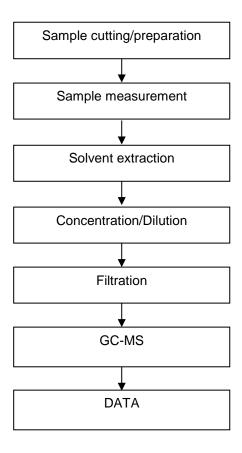


